# Country and Marine Parks Authority Progress Report (1.1.2022 – 30.4.2022)

# **Purpose**

This paper aims to provide members a general overview on management and protection work conducted by the Country and Marine Parks Authority during the period between 1.1.2022 and 30.4.2022. It provides various figures and information for facilitating members to understand and offer advice to the Authority regarding the management of country and marine parks.

## A. Country Parks & Special Areas

## 1. Country Parks Management

## 1.1 Management Services

Routine maintenance of all recreational facilities within county parks and special areas was carried out regularly for public enjoyment. Major country parks facilities provided and amount of refuse collected are shown below for reference.

## 1.4 Control of Development

### **2.2** Visitor Centres

In light of the situation of the COVID-19 in Hong Kong, Country Park Visitor / Education Centres, except the outdoor exhibition area of Lions Nature Education Centre and permit counter of Sai Kung Country Park Visitor Centre, were temporarily closed from 7 January to 20 April 2022. The country park school and public education programmes at visitor / education centres remain suspended. # 2.3 Country Park Volunteer Scheme

The Country Park Volunteer Scheme commenced in March 2010. In light of the situation of the COVID-19, volunteer services were suspended during the reporting period. The number of volunteers and trainees was maintained at 759 persons.

# 2.4 School Visit Programme

School visit programme was launched again in 2021-22 school year to convey nature conservation message to students. To facilitate the special class arrangements of schools, an online programme was introduced from April 2021. Education Bureau announced a special vacation arrangement for all schools from 7 March to 19 April 2022 due to the fifth wave of the COVID-19 epidemic, the school visit programme was suspended for that period. ### 3. Law Enforcement

The taskforce on sea enforcement work related to the Marine Parks Ordinance (Cap. 476) and Fisheries Protection Ordinance (Cap. 171) was established to enhance synergistic effect. During the report period, one illegal fishing incident in Hong Kong waters involving one mainland fisherman was successfully prosecuted while 2 advisory letters were issued to 2 local fishing vessel owners. One case of illegal fishing was under investigation. In addition, for marine parks and marine reserve, a total of 280 advices and 6 verbal warnings were given, and 10 suspected offense cases were under investigation.
