

## 漁產品的輻射水平測試結果

(截至 2017 年 5 月 31 日)

### Results of Radiological Testing of Fishery Products

(As of 31 May 2017)

漁農自然護理署(漁護署)定期在魚類養殖區及魚類統營處批發市場採集樣本進行輻射水平測試。

漁護署將於網頁上更新測試的最新數字，包括含低輻射量但未超出《食品法典委員會》指引限值\*的樣本結果。

The Agriculture, Fisheries and Conservation Department (AFCD) collects samples from local fish culture zones and wholesale markets under the Fish Marketing Organization (FMO) for radiological testing on a regular basis.

AFCD will update the testing results on the website, including samples detected with low radioactivity level not exceeding the guideline levels of the Codex Alimentarius Commission\*.

Note 註1. 兩個分別於二零一一年五月二十七日及二零一一年九月二十二日採集的樣本驗出含微量碘 -131，沒有超出《食品法典委員會》的指引限值。

Two samples collected on 27 May 2011 and 22 September 2011 respectively were found to contain trace amount of Iodine -131 not exceeding the guideline level of the Codex Alimentarius Commission.
