<p>1. 請用<b>正楷</b>填寫，填妥後申請人或其代表必須親自將申請表送回九龍長沙灣道 303 號 5 樓 9 號櫃位漁農自然護理署簽證及認證組，遞交申請表格時須一併繳付申請費用。不論獲發健康證書與否，已繳付之費用均不予以退還。切勿郵寄現金。如用支票付款，收款人須寫明「香港特別行政區政府」。</p> <p>2. 動物及禽鳥的物主/出口商<b>必須</b>預先查核及確保已符合目的地國家/地方的所有進口規定。請預先向目的地國家/地方的有關部門或該國駐港的領事館查詢入口規定。</p> <p>3. 簽發官方動物健康證書/官方核證資料服務只提供予指定要求的入口國家。</p> <p>4. 獲簽發的動物健康證書或在動物健康證書上加簽不應被理解為已符合目的地國家/地方的所有進口規定。</p> <p>5. 動物健康證書的有效期將視乎目的地國家/地方的規例而定，通常在簽發日期起計的 10 天內有效。</p> <p>6. 倘申請人或其代理未能依照本署獸醫師要求提供足夠的資料或所提供的資料真偽存疑，本署將拒絕簽發/加簽動物健康證明書，並將已繳費用沒收。</p> <p>7. 倘日後你將有關的動物或禽鳥帶返香港，則<b>必須</b>： (a) 預先向本署申請一份有效的許可證；及 (b) 遵守該證上所列的條件及規定。</p> <p>8. 如帶返香港的動物屬<b>貓狗</b>類別，除遵守以上規則外，更須符合以下要求： (a) 該動物仍須在<b>外遊國/地方</b>連續居住滿6個月，期間該地並無發生狂犬病；或 (b) 倘該動物在<b>外遊國/地方</b>居留少於6個月，畜主須在離港前向本署申請並獲發一份<b>*居留證明豁免書</b>，並須符合該豁免書內的規定；否則有關動物在回港後有可能要接受長達 6 個月的檢疫期，檢疫費用由物主支付。</p> <p>* 申請居留證明豁免書，應於辦理動物健康證書同時辦理。居留證明豁免書並不適用於從有發生狂犬病的國家/地方即第三組國家/地方帶返香港的動物，該動物需要接受長達 6 個月的檢疫期，檢疫費用由物主支付。</p> <p>9. 詳細資料可瀏覽本署網頁<a href="http://www.afcd.gov.hk">http://www.afcd.gov.hk</a>或辦公時間內致電 2150 7065 查詢。</p>	<p>1. Please complete in <b>BLOCK LETTERS</b>. The applicant or his/her representative must submit the completed application form at Counter No.9, Permit &amp; Certification Section, Agriculture, Fisheries and Conservation Department, 5<sup>th</sup> Floor, Cheung Sha Wan Government Offices, No.303 Cheung Sha Wan Road, Kowloon, Hong Kong. Application fees must be paid upon the submission of the application. The fees are NOT refundable no matter the certificate has been approved or not. Cash should not be sent by post. Cheque and bank draft should be made payable to "The Government of the Hong Kong Special Administrative Region".</p> <p>2. The owner/exporter of the animals/birds <b>MUST</b> check and ensure that he/she satisfies <u>all</u> import requirements of the destination country/place. Import requirements should be checked with the authority in the destination country/place or the consulate in Hong Kong.</p> <p>3. The issue of an official animal health certificate/ official certification of information is only provided for the importing countries which specifically require such service.</p> <p>4. Endorsement or the <u>issue</u> of an Animal Health Certificate <u>cannot</u> be construed as full compliance with all the import requirements of the destination country/place .</p> <p>5. The period of validity of the certificate will depend on the regulations of the destination country/place. In general, it is valid for 10 days from the date of issue.</p> <p>6. In case the applicant or his/her agent is unable to provide sufficient information upon the request of the veterinary officer of this Department or the authenticity of the provided information is in doubt, this Department will refuse to issue/endorse the animal health certificate, and the fee will be forfeited.</p> <p>7. If you wish to bring your pets back to Hong Kong, you <b>must</b>: (a) apply for a permit from this department in advance; and (b) comply with all the terms and conditions stated on the permit.</p> <p>8. If the re-imported pets are <b>dogs/cats</b>, apart from the requirements listed in the foregoing sections, you should ensure that your pet will meet the following requirements: - (a) The said animal has been continuously residing in the <b>country/place of visit</b> during the preceding six months in a rabies free area; OR (b) If the period of stay in the <b>visiting country/place</b> is less than 6 months, the animal should be accompanied by a <b>*Residence Certification Waiver</b> issued by this department prior to the animal's departure from Hong Kong.</p> <p>Failing to comply with the above, the animal may be quarantined for up to six months at the owner's expense.</p> <p>* The application for the issue of the Waiver must be made at the same time when you apply for the health certification. The Waiver is not applicable to dogs / cats coming from confirmed rabies infected countries/places (Group III Countries). The animals must be quarantined for a period up to 6 months at owner's expense.</p> <p>9. 如你需要再度攜帶已出口的動物及禽鳥回港，請預先向本署申請許可證，否則即屬違法。

A permit granted by this Department is required in advance if you intend to re-import your animal(s) / bird(s) into Hong Kong, otherwise you will contravene the law.

### 免責聲明 Disclaimer

你應預先向目的地國家/地方的有關部門，及/或該國/地方駐港的領事館查詢入口規定，確保已符合目的地國家/地方的所有進口規定。在處理申請時，本署已力求審慎，惟簽發動物健康證書或在動物健康證書上加簽並不保證已符合所有進口規定。漁農自然護理署或其任何職員，均毋須為簽發或加簽的證書承擔任何賠償責任。本署亦不會對任何動物及禽鳥被遣返所引起的費用作出賠償。如被遣返的動物及禽鳥並沒有領有有效的許可證，你將會被檢控。

You **MUST** check and ensure in advance that you satisfy all import requirements of the destination country/place. Endorsement or the issue of an Animal Health Certificate does not guarantee that it is sufficient. Import requirements should be checked with the authorities in destination country/place, consulate in Hong Kong. Whilst every care has been taken in processing the application, in particular, no warranty regarding foreign importation requirements is given in conjunction with the application. Our Department will not be liable to any claim with respect to the issuance/ endorsement of any Animal Health Certificate or cost incurred due to the repatriation of animals or birds. If the repatriated animals /birds are not covered by a valid permit, you will be prosecuted.
