<p>此證明書須在有關動物離境前 14 天內簽發。證明該動物並無傳染或觸染疾病的病徵，其健康狀況許可將之運送至香港，且該動物（倘屬雌性）並無懷孕或即懷孕亦不足 4 星期。證明書上要有該動物詳細的微型晶片(宜用9位數字的AVID型號晶片)資料足以證實該動物的正確身份。(注意：請參閱備註欄。)</p> <p>Dated not more than 14 days before the departure of the animal(s) certifying that the animal is free from any clinical signs of infectious or contagious disease, fit to travel and is either not pregnant or less than 4 weeks pregnant if it is a female. The certificate must be positively correlated to the animals being certified by inclusion of the identifying microchip details. (Note: A blank copy of the Airline Certificate (Form No. PC101) will be provided for completion by relevant Airlines.)</p>
<p>備註Remarks:</p> <ul style="list-style-type: none"> ● 年齡未足60日大或懷孕多於 4 星期的貓狗不得入口。Dogs and cats less than 60 days old and or more than 4 weeks pregnant must not be imported. ● 在出口時倘屬不足12 星期大的小狗，該小狗在 6 星期大後及出口前不少於 10 天除了犬瘟熱的疫苗外，亦已使用麻疹疫苗以對抗犬瘟熱；及接受防疫注射對抗犬病毒性出血腸炎。該動物並已根據疫苗製造商的指示，接受適用於該年歲動物之防疫注射。證書並須明確註明日後加強防疫注射的日期。(如不能接受麻疹疫苗注射，則有關麻疹疫苗的規定可毋須遵行。但狗隻必須接受已在出口國/地方註冊的疫苗注射，以預防犬瘟熱、犬病毒性肝炎及犬病毒性出血腸炎)。狗隻必須有抵抗犬隻疾病的首次防疫注射記錄，而入口者須安排香港註冊獸醫作跟進注射。 A puppy under 12 weeks of age at the time of export must have been vaccinated at not less than 6 weeks of age and not less than 10 days preceding export against Canine Distemper using Measles vaccine in addition to Distemper vaccine and against Canine Parvovirus. The animal must have been fully vaccinated according to the vaccine manufacturer's recommendations for animals of that age. The recommended dates for follow-up (booster) vaccinations must be clearly stated in the vaccination certificate. (If it is not possible to obtain the measles vaccine, the requirement for measles vaccine will be omitted if not already done. However, the puppy should be vaccinated against distemper, hepatitis and parvovirus using vaccine(s) registered for use in the country of export for young puppies. The dogs must have a full initial vaccination record against the canine diseases, and the importer should have arrangements in hand for follow-up vaccinations by a registered veterinary surgeon in Hong Kong.) ● 動物健康證明書、居留證明書及傳染病防疫注射證明書合併為一份證明書亦可予接納。證明書須由政府獸醫官簽署及蓋章；或經註冊之獸醫簽署及蓋章及由政府獸醫官加簽。A combined Animal Health, Residence and Vaccination Certificate is acceptable.
