Animals will not be released from quarantine unless they are over 5 months old. ● 動物健康證明書，居留證明書及傳染病防疫注射證明書合併為一份證明書亦可予接納。證明書須由政府聘任之全職獸醫官簽署及蓋章；或經註冊之獸醫簽署及蓋章及由政府聘任之全職獸醫官加簽。A combined Animal Health, Residence and Vaccination Certificate is acceptable.
