<p>此證明書須在有關動物離境前 14 天內簽發。證明該動物並無傳染或觸染疾病的病徵，其健康狀況許可將之運送至香港，且該動物(倘屬雌性)並無懷孕或即懷孕亦不足 4 星期。證明書上要有該動物詳細的微型晶片(宜用9位數字的AVID型號晶片)資料足以證實該動物的正確身份。(注意：請參閱備註欄。)</p> <p>Dated not more than 14 days before the departure of the animal(s) certifying that the animal is free from any clinical signs of infectious or contagious disease, fit to travel and is either not pregnant or less than 4 weeks pregnant if it is a female. The certificate must be positively correlated to the animals being certified by including the identifying microchip details. <p><b>備註Remarks:</b></p> <ol style="list-style-type: none"> <li>1. 年齡未足60日大或懷孕多於 4 星期的貓狗不得入口。貓狗進口時若不足5個月大必須接受檢疫至超過 5 個月齡才能離開檢疫狗房。Dogs and cats less than 60 days old and or more than 4 weeks pregnant must not be imported. Animals will not be released from quarantine unless they are over 5 months old.</li> <li>2. 動物健康證明書，居留證明書及傳染病防疫注射證明書合併為一份證明書亦可予接納。證明書須由政府聘任之全職獸醫官簽署及蓋章；或經註冊之獸醫簽署及蓋章及由政府聘任之全職獸醫官加簽。A combined Animal Health, Residence and Vaccination Certificate is acceptable.
