**第十七屆《瀕危野生動植物種國際貿易公約》締約國大會
通過的附錄 I 及 II 修訂**

繼本署於 2016 年 8 月 8 日就有關修訂《瀕危野生動植物種國際貿易公約》(簡稱《公約》)附錄的提案發出通函(編號 ES05/16)後,現謹通告,本年 9 月 24 日至 10 月 4 日於南非約翰內斯堡舉行的第十七屆《公約》締約國大會已完滿結束,並通過部分對《公約》附錄 I 及 II 的修訂提案。現將已獲通過的《公約》附錄 I 及 II 修訂撮述於本署網頁 www.cites.hk 的「最新消息」內。本署現正著手進行香港法例第 586 章《保護瀕危動植物物種條例》的修訂,稍後將另函通告相關詳情。

本港將會在法例第 586 章的修訂工作完成後,才開始實施對上述《公約》附錄 I 及 II 變動的新管制,然而,本署現提醒各位業內人士,《公約》附錄 I 及 II 的修訂已於 2017 年 1 月 2 日正式生效(於附件特別註明的鯊魚及蝠鱝品種除外),部分國家及地區可能已由該日開始對新列入附錄的物種採取相關的進、出口管制措施,並要求就有關的付運貨物提供《公約》進、出口文件。在進行貿易時,請留意及遵守各個國家的《公約》要求,若有需要時本署將盡量提供協助。
