Total fines for the period is \$115,550, which also includes the fines partly collected from cases carried forward from previous reporting periods and partly from current period. One prosecution case against damaging plant/erection of structure in Lantau South Country Park, the summons was withdrew on 31.8.2012 after the defendant had restored the affected areas in the country park to the satisfactory of the Authority. There is no other unsuccessful prosecution case in the reporting period.

VI. CONTROL OF DEVELOPMENT

A total of 79 development proposals were received. There was no objection to 46 of them, the other 33 were being processed. Most of these were related to minor works concerning electric supply and slope works.

VII. EDUCATION/VISITOR SERVICES

(1) No. of Visits to Visitor Centres

A total of 247,426 persons visited the Country Park Visitor Centres and Education Centres. In which, 127,043 persons visited Sai Kung, Aberdeen, Shing Mun, Clear Water Bay, Tai Mo Shan and Plover Cove Country Parks Visitor Centres; 11,318 persons visited Woodside Biodiversity Education Centre; 88,525 persons visited Lions Nature Education Centre and 20,540 persons visited Ngong Ping Nature Centre.

(2) <u>Video Shows of Country Parks</u>

A total of 12,009 video shows on country parks and nature conservation were given, reaching an audience of 40,236. Besides, the "Songs of Nature" were played at various Visitor Centres to promote the voted Best Scenic Sites of Hong Kong.

(3) Guided Tour

A total of 1,722 participants from 44 organizations joined the guided tour at Lions Nature Education Centre; 727 participants from 62 groups joined the guided walk at Ngong Ping Nature Centre; 338 participants from 9 groups joined the guided tours at Pineapple Dam Nature Trail which is newly established in July 2012.

(4) Fixed Point Guided Tour

From May to August 2012, a total of 21,455 participants from 846 organizations joined the Fixed Point Guided Tour at Lions Nature Education Centre; a total of 231 participants from 24 organizations joined Tai Po Kau Forest Walks Fixed Point Guided Tour.

(5) Country Park Volunteer Scheme

The Country Park Volunteer Scheme has been commenced since March 2010. For the period from 1 May to 31 August 2012, a total of 124 volunteers completed the basic training. At present, there are 876 volunteers. After the volunteers completed the training, they will assist the organization of various nature conservation and education activities of the country parks. From 1 May to 31 August 2012, total number of volunteer served hours are 10,812 hours.

(6) School Visit Programme

A school visit programme was launched since November 2011 to convey nature conservation message to students. From May to June 2012, a total of 3,560 students from 15 primary schools and 1,739 students from 25 kindergartens joined the programmes respectively.

(7) Tree Walks Guided Tour

From May to August 2012, a total of 332 participants from about 78 organizations joined the Tree Walks Guided Tours at Quarry Bay Tree Walks and Ngong Ping Tree Walks.

(8) "Nature Appreciation - Practice" Country Park Education Activities

From May to August 2012, a total of 13 "Nature Appreciation – Practice" activities were carried out. A total of 326 kindergarten and primary students joined the activities.

(9) Guided Field Study for Secondary Schools

A new education programme – "Nature in Touch" Country Parks Guided Field Study for Secondary Schools has been launched since January 2012. In May 2012, a total of 942 secondary students from 49 schools participated in the Guided Field Study at Lions Nature Education Centre, Tai Po Kau Nature Reserve and Shing Mun Country Park. The contractor guides the students to understand the concept and importance of the biodiversity, nature conservation and sustainable development in Hong Kong with the use of worksheets provided in "Hong Kong Country Parks Education Kit for Secondary Schools".

(10) School Guided Eco-Tours Service 2012

The department organized free guided tours to schools from May to June 2012. Through the activity, students can learn about the geology, ecology and cultural heritage in the High Island, Sharp Island and Jin Island in Sai Kung. A total of 140 primary and secondary students from 11 groups participated in the Guided Tour. The programme will be resumed in October to December 2012.

(11) "Country Parks Orienteering" Programme

From March to June 2012, the department organized the "Country Parks Orienteering" programme for students to experience orienteering and to learn about the country parks. A total of 29 schools 690 students participated.

(12) Hiking and Planting Day 2012

In order to promote public awareness on nature conservation and tree preservation, the Agriculture, Fisheries and Conservation Department and the Friends of the Country Parks has jointly hold the Country Parks "Nature in Touch" Hiking and Planting Day in April and May 2012. A total of 3,308 participants planted 6,000 trees in Fu Tei, Tai Lam Country Park and Sheung Miu Tin, Plover Cove Country Park.

(13) Woodside Biodiversity Education Centre Opening Ceremony

Woodside Biodiversity Education Centre Opening Ceremony was held on 1 June 2012 with 56 guests presented. The Centre comprises three themed exhibition galleries introducing Hong Kong's precious natural resources and biodiversity, multi-function conference room, resources centre, activity room and a nature trail. The Centre aims to foster public awareness, knowledge and understanding the inherent value of Hong Kong's biodiversity assets and to marshal public support and action for nature conservation.

(14) Shing Mun Country Park Visitor Centre Opening Ceremony cum Book Launching Ceremony of Country Parks Tree Walks

Shing Mun Country Park Visitor Centre was re-opened on 14 July 2012 after renovation. The Exhibition Gallery of the Centre is composed of four themes, namely, history of Shing Mun Country Park; mining activity; war relics; and biodiversity in Shing Mun Country Park. The Centre is designed to provide a self-learning platform for students and the general public and to arouse their awareness of the importance of nature conservation. The opening ceremony was held together with the Book Launching Ceremony of "Country Parks Tree Walks", a total of 42 guests presented. Covering 96 species of trees and other interesting plants commonly found in tree walks of Hong Kong country parks, this book, Country Parks Tree Walks, is written in plain language and includes photographs and illustrations showing the features of each plant.

2. <u>LAW ENFORCEMENT AND ADVICE</u>

During the report period, a total of 532 advices and 121 verbal warnings were given to fishermen and visitors and 22 prosecutions were taken against offenders in marine parks and marine reserve.

2.2 A joint enforcement operation with Fisheries Enforcement Agency of Guangdong Province and Hong Kong Marine Police had been carried out on 10 May 2012 to combat illegal cross-boundary fishing activities at Mirs Bay. AFCD inspected and intercepted 7 mainland vessels involving 11 mainland fishermen during this operation. The vessels were found within Hong Kong waters and none was reported in the marine park areas. With the assistance of Hong Kong Marine Police, all the arrested fishermen and their fishing vessels were returned to Mainland counterparts. The joint enforcement operation is considered successful.

5. <u>MONITORING</u>

5.1 Water Quality Monitoring

The Hong Kong University of Science and Technology was commissioned to carry out water quality monitoring in marine parks and marine reserve in 2011-12. The results are generally good and in compliance with the Water Quality Objectives. A summary result of water quality statistics of 2007 – March 2012 has been uploaded onto the AFCD's homepage (http://www.afcd.gov.hk/english/country/cou_vis/cou_vis_mar/cou_vis_mar_mon/cou_vis_mar_mon_wat.html_).

5.2 <u>Fishing Survey</u>

- 5.2.1 Fishing survey at Cape D' Aguilar Marine Reserve continued. The objective is to investigate the long-term enhancement effect of the marine reserve on fisheries resources. The recent result showed that the Catch-per-unit-effort and the diversity of fish remain stable inside the marine reserve and is higher than surrounding waters.
- 5.2.2 Quarterly fishing surveys at Hoi Ha Wan, Yan Chau Tong and Tung Ping Chau Marine Parks have been carried out to monitor the fish stocks in the three marine parks. The Catch-per-unit-effort and the diversity of fish inside the marine park are general better than outside the marine parks area.

5.3 <u>Dolphin Sightings</u>

Off-effort dolphin sighting were conducted during the course of patrol of Sha Chau and Lung Kwu Chau Marine Park. It was evident that Chinese White Dolphins utilize the marine parks and the waters around as usual.

6. EDUCATION AND VISITOR SERVICES

Ouring the report period, there was a decrease in visitors' number in Hoi Ha Wan, Yan Chau Tong and Sha Chau and Lung Kwu Chau Marine Parks. The decrease may be the result of more frequent adverse weather (number and duration of typhoon) when compared with the same period in the last year. While an increase was recorded for Tung Ping Chau Marine Park, which may be attributed to the shift in interest to geological scenic spots due to the announcement of Hong Kong Global Geopark of China, which surpassed the weather effect. During the report period, Marine Parks Ambassador participated in the following volunteer services: Hoi Ha Wan Marine Park Visitor Code Promotion, Hong Kong Reef Check 2012 Opening Ceremony, Hong Kong Underwater Photo and Video Competition 2012 – Underwater Photography Workshop, and Yan Chau Tong Marine Park Coastal Cleanup. A total of 36 ambassadors joined the above activities.

Marine Parks Visitor Code Promotion was held on 19 August 2012 at Hoi Ha Wan Marine Park. The activity aimed to promote the Marine Parks Visitor Code and educate the visitor how could they help to conserve the ocean. A total of 10 Marine Parks Ambassador joined the activity to assist the Division to distribute the visitor code card and answer the enquiries about Marine Parks. Through the activity, the ambassadors explained the background and works of Marine Parks in Hong Kong to 120 visitors.

- 6.6 Marine Parks Division organize a series of Public Seminar on Marine Parks and Marine Ecological Resource every year. Different marine ecologists are invited to share the wonderful marine world in Hong Kong with the citizens. Five seminars were organized in July and August 2012 at Hong Kong Cultural Centre with 342 participants.
- 6.7 Marine Parks Division has launched "Marine Based Guided Tours Exploration of fishermen culture and marine resources in Hong Kong" for all secondary schools starting from October 2010. During the report period, 19 tours were held with 614 participants. To advance the sustainability of the Marine Based Guided Tours for long-term livelihood of the fishermen, the Division has coordinated the development of commercial tours for open public since October 2011. During the report period, 7 commercial tours were held with 174 participants.
- Up to 31 August 2012, a total of 81 Marine Parks Ambassadors had completed 20 hours services; 33 Ambassador had completed 40 hours services; 20 Ambassadors had completed 70 hours services; 13 Ambassadors had completed 100 hours services, 6 Ambassadors had completed 150 hours services and 1 Ambassador completed 200 hours service. They were awarded with the Jellyfish Service Badge", "Nautilus Service Badge", "Fiddler Crab Service Badge", "Starfish Service Badge", "Humphead Wrasse Service Badge" and "Chinese White Dolphin Service Badge" respectively. Until the end of August 2012, the accumulated service hours of marine parks ambassadors are 6,024 hours.
