- 為方便農友,漁護署與地政總署現正進行一站式優化農用構築物批准書(LoA)及豁免證明書(CoE)申請計劃。
 For the convenience of farmers, AFCD and the Lands Department (LandsD) are currently conducting a one-stop optimization of Letter of Approval for Agricultural Structures on Private Agricultural Land (LoA) and Certificate of Exemption (CoE) application scheme.
- 於新安排下,農友可經漁護署向地政總署**同時**遞交 LoA 及 CoE 之申請。
 - (1) 如擬建的農用構築物有蓋面積大於 5,000 平方呎 (464.51 平方米) 而不涉及興建關鍵構件,則需連同由**建築 承建商及 T2 合資格人士**簽署之聘任書一併遞交。
 - (2) 如擬建的農用構築物有蓋面積大於 1,000 平方呎 (92.90 平方米) 而涉及興建關鍵構件,則需連同由建築承建 商及 T2 合資格人士再加上註冊結構工程師/註冊專業工程師簽署之聘任書一併遞交。

Under the new arrangement, farmers can submit applications for both LoA and CoE to LandsD through AFCD.

- (1) If the roofed-over area of any proposed agricultural structures exceeds 5,000 ft² (464.51 m²) without involving construction of critical structural elements, please also submit a letter of appointment from **Building Contractor and T2 competent person**.
- (2) If the roofed-over area of any proposed agricultural structures exceeds 1,000 ft² (92.90 m²) but involving construction of critical structural elements, please also submit a letter of appointment from **Building Contractor and T2 competent person** together with that of **Registered Structural Engineer/Registered Professional Engineer**.

- 為減省處理申請所需的時間,漁護署經初步審視後,會把申請文件送呈各相關部門同步提出意見,然後一併向地 政總署作出建議。
 - In order to reduce the time for processing applications, after a preliminary review, AFCD will send the application documents to the relevant departments for comments at the same time, and then make suggestions to LandsD.
- 地政總署接獲漁護署及相關部門對有關申請的意見後,會再進一步考慮是否簽發 LoA 及 CoE。若申請獲得批准, LoA 及 CoE 均由地政總署直接發給申請人。如申請不獲批准,地政總署會發信通知申請人,解釋不予批准的理 中。
 - LandsD will further consider whether to issue LoA and CoE after receiving the comments of AFCD and relevant departments for the application. If the application is approved, both the LoA and CoE will be issued directly to the applicant by LandsD. If the application is turned down, LandsD will inform the applicant in writing with reason(s) given.
