## 注意事項 Notes:

- 1) 遞交此申請表並不表示申請已獲批准。  
Submission of this application does NOT mean approval of ownership transfer of a Marine Fish Culture Licence will automatically be granted.
- 2) 填妥的申請表須連同申請所需費用及海魚養殖業牌照正本一併遞交。  
The completed application form must be submitted with the prescribed fee and the original of the existing licence to be transferred.
- 3) 在該持牌人持有該牌照少於兩年的情況下，申請將不獲批准。  
Application will be refused if the licence was held by the licensee for less than two years.
- 4) 申請成功與否，申請費用不獲發還。  
Whether successful or not, the application fee is not returnable.
- \*\* 5) 受讓人必須是申請人所屬魚類養殖區的現有持牌人。  
The transferee must be an existing licensee of the same fish culture zone as the applicant.
- \*\* 6) 受讓人須能在其魚場四周容納轉讓得來的面積而不影響鄰近養魚戶。  
The transferee must be able to accommodate the acquired area around his/her existing farm without causing interference to neighbouring mariculturists.
- \*\* 7) 轉讓後，持牌人餘下的牌照面積不能少於 50 平方米。  
The remaining portion of the applicant's licence area shall not be smaller than 50m<sup>2</sup> after the intended transfer.
- \*\* 8) 涉及轉讓的魚排在轉讓後不能由持牌人及受讓人共同擁有。  
Any raft involved in the transfer shall not be owned by both the applicant and the transferee after the intended transfer.
- \*\* 9) 在轉讓後，申請人魚排上的現有搭建物可能會超出規定，他/她必須在轉讓獲批准後 30 天內拆除所有過大的搭建物。  
The transfer may result in the existing structures on the applicant's rafts exceeding the allowed limits, such oversized structures shall be demolished within 30 days after approval of the transfer.
