



 5. 申請／續領研究捕魚許可證的費用為\$365，繳付的費用概不退回。
 6. 申請人須於其地址變更後7天內，藉書面通知將該項變更告知漁農自然護理署署長。
 7. 申請人必須就申請所涉船隻出示有效的運作牌照正本以供檢查，如以郵寄方式遞交申請書，本署職員會聯絡申請人／獲授權人，安排檢查時間。
 8. 申請人或須應本署要求而交出申請所涉船隻(包括其附屬船隻)以供檢查。
 9. 申請人與政府部門進行任何事務往來時，均不應向該政府部門的職員提供利益。
 10. 如申請人並非有關船隻的船東，本署亦會將申請結果以郵寄方式通知該船隻船東。
 11. 如申請人因漁農自然護理署署長一拒絕根據《漁業保護條例》(第171章)第25條所指的研究捕魚許可證發出或續期的申請；根據第25(3)條施加條件；或根據第29條取消研究捕魚許可證的決定而感到受屈，申請人可在漁農自然護理署署長的決定之通知書的日期起計21日內，向行政上訴委員會提出上訴。

 2. If the application is submitted by an authorized person or made by the authorized person on behalf of the applicant, the authorized person is also required to produce his/her own original identity document and the authorized letter made by the applicant for record purpose.
 3. Pursuant to section 35 of the Fisheries Protection Ordinance, Cap. 171, the Director of Agriculture, Fisheries and Conservation may obtain from the Director of Marine any particulars or information relating to a vessel (including particulars of its owner) for any purpose in connection with any matter relating to fishing, registration of local fishing vessels or any research fishing permit. The Director of Marine may supply any particulars or information as abovementioned.
 4. Pursuant to section 36 of the Fisheries Protection Ordinance, Cap. 171, a person who, for the purpose or procuring, whether for the person or any other person, the registration of a fishing vessel or alteration to any vessel particulars or conditions for registration or the issue or renewal of a research fishing permit, makes a declaration or statement, or furnishes any information or document, knowing it to be false or misleading as to a material particular, commits an offence and is liable on conviction to a fine at level 5 and to imprisonment for 3 months.
 5. The fee for an application for the issue or renewal of a research fishing permit is \$365. The fee is non-refundable regardless of the result of the application.
 6. The applicant should inform the Director of Agriculture, Fisheries and Conservation by notice in writing of his/her change of address within 7 days of the change.
 7. The applicant shall produce the original valid operating licence in respect of the vessel to which this application is related to the Director of Agriculture, Fisheries and Conservation for inspection. If an application is submitted by post, this Department would contact the applicant/authorized person to make arrangement for inspection of the operating licence.
 8. This Department may require the applicant to produce the vessel (including its ancillary vessels) in respect of which the application is made for inspection.
 9. Applicants must not offer any advantages to government officials.
 10. If the applicant is not the owner of the vessel, this department will also inform the result of the application by post to the vessel owner.
 11. The applicant aggrieved by a decision of the Director of Agriculture, Fisheries and Conservation – refusing an application for the issue or renewal of a research fishing permit under section 25 of the Fisheries Protection Ordinance, Cap. 171; imposing conditions under 25(3) or cancelling a research fishing permit under section 29 may, within 21 days from the date of the notice of the decision of the Director of Agriculture, Fisheries and Conservation, appeal to the Administrative Appeals Board.

9. Two 3R to 8R sized photographs showing clearly the entire port and starboard sides of the vessel
