**Protection of Endangered Species of Animals and Plants
Ordinance (Amendment of Schedules 1 and 3) Order
2018**

(Made by the Secretary for the Environment under section 48 of the
Protection of Endangered Species of Animals and Plants
Ordinance (Cap. 586))

1. Commencement

This Order comes into operation on 1 November 2018.

**2. Protection of Endangered Species of Animals and Plants

- (ii) that wording, mark or logo must appear on the reverse side of the cloth; and
 - (iii) the selvages of the cloth must bear the words “VICUÑA [COUNTRY OF ORIGIN]”;
- (c) for marketed garment made from live-sheared vicuña fibre, whether the garment is produced within or outside the range states of the species—
 - (i) the wording, mark or logo referred to in paragraph (b)(i) must be used;
 - (ii) that wording, mark or logo must appear on a label in the garment itself; and
 - (iii) if the garment is produced outside the country of origin, the name of the country where the garment is produced must be indicated, in addition to that wording, mark or logo;
 - (d) for a handicraft product made from live-sheared vicuña fibre produced within the range states of the species—the “VICUÑA [COUNTRY OF ORIGIN] – ARTESANÍA” wording, mark or logo having the format specified in Diagram 2 (with the country of

origin identified within the square brackets) must be used—

Explanatory Note

The main purpose of this Order is to amend Schedules 1 and 3 to the Protection of Endangered Species of Animals and Plants Ordinance (Cap. 586) (*Ordinance*) to give effect to—

- (a) the changes made in September and October 2016 to the listings of endangered species in Appendices I and II to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (*Convention*);
- (b) the changes made since the last amendment of the Ordinance in 2014 to the listings of endangered species in Appendix III to the Convention;
- (c) the changes made in September and October 2016 to the resolutions adopted by the Conference of the Parties to the Convention; and
- (d) the technical amendments arising from the updates in nomenclature, rectification to nomenclature and provision of common names to species names.
