Proposals for amendment of the Appendices to CITES

I would like to draw your attention that proposals have been received by the Secretariat of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) for amendments of Appendices to CITES, including proposals concerning some species of lizards, turtles and salamanders used as pets, some species of sharks, rays and sea cucumber used as food, and some plant species used for timber. These proposals will be discussed at the 18th meeting of the Conference of the Parties to CITES which will be held in Colombo, Sri Lanka from 23 May to 3 June 2019. Should the proposals be adopted, amendments of the Protection of Endangered Species of Animals and Plants Ordinance, Cap. 586 will be initiated, in order to give effect to the changes in regulation of the trade in endangered species.
