### Amendment to the Protection of Endangered Species of Animals and Plants Ordinance

Further to our circular letter No. ES 08/09 of 27 November 2010, please be informed that some of the proposals to amend the Appendices to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) have been adopted at its 15th meeting of the Conference of the Parties. This department has also made corresponding amendments to the Protection of Endangered Species of Animals and Plants Ordinance (the Ordinance). The amendments were published in the Gazette on 25 February 2011 and the new controls will come into operation on 20 May 2011. Please refer to the Gazette (http://www.gld.gov.hk/egazette/) for details of the new controls. Amendments regarding the endangered species scheduled to the Ordinance are summarized in Annex to this letter.

When the above new controls take effect, all newly listed species will be subject to licensing control. According to the Ordinance, unless exempted, the import, introduction from the sea, export, re-export or possession of endangered species (including their parts and derivatives) requires a licence issued in advance by this department.

Traders now in possession of stock of the newly listed species for commercial purposes are required to declare to this department their existing stock on or before 19 May 2011 to facilitate re-export after the commencement of the new controls.
