Proposals for amendment of the Appendices of CITES

I would like to draw your attention that proposals have been submitted to the Secretariat of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) to amend the Appendices of CITES, including proposals concerning some reptile, amphibian and bird species used as pet, some shark and ray species used as food, as well as some plant species used as ornaments and timber. These proposals will be discussed at the 17th meeting of the Conference of the Parties (CoP17) to CITES which will be held in Johannesburg, South Africa at the end of September 2016. Should the proposals be adopted, amendments of the Protection of Endangered Species of Animals and Plants Ordinance, Cap. 586 will be initiated, in order to give effect to the changes in regulation of the trade in endangered species.
