1. First-come, First serve basis. **Each organization can only submit 1 application form and reserve 2 sessions.** Please fax (**2667 8212**) or email (**tpgeopark@taipoea.org.hk**) the completed application form to the Association **a month before the Tour.** All applications will be preceded until all quotas are filled. All applications will be handled and answered within 3 working days. For any enquiries, please contact us at **2667 0992.**
2. Please provide the participant name list to the Association via fax or email **a week before the activity day.**
3. **Participants must be aged 12 or above; Participants between the ages of 12 and 16 must be accompanied by adults. Each adult can only bring along two aged 12 to 16 years participants.**
4. **The Programme is conducted outdoor. To comply the safety consideration, this programme is not recommended for any person who is not physically fit.**
5. Gloves, rubbish bags and data cards for recording collected marine debris will be provided.
6. The Programme will be mainly conducted in Cantonese. To arrange an English speaking session, please indicate on the application form. After finishing the coastal clean-up, a short session of ecotour will be delivered.
7. Participants are recommended to wear suitable clothing and shoes (e.g. long-sleeved clothing with light color, sports or hiking wear), bring sufficient amount of water, reusable water bottle and prepare other useful outdoor equipments, such as sunscreen, umbrella, mosquito repellent and etc, on the activity day.

 - a) Thunderstorm Warning, Rainstorm Signal or Tropical Cyclone Signal: The Programme will be cancelled if Thunderstorm Warning; Yellow Rainstorm Signal or above; or Tropical Cyclone Signals No.3 or above, is issued by the Hong Kong Observatory 2 hours before the Programme starts or during the Programme.
 - b) Inclement weather: The Programme will be cancelled even if the above signals are not hoisted by the Hong Kong Observatory when the territory is under unstable weather condition such as heavy showers and squally thunderstorms, interpreter will inform participants of the cancellation 2 hours before the Programme starts or during the Programme.
