Summary of the views collected:

- The seafood trade did not have a strong view on the proposed application of the Convention to Hong Kong and the proposed control scheme for the trading of toothfish.
 Some of the importers were supportive of the proposal as it would help protect the marine resources and deter some to import toothfish obtained from illegal sources.
- Importers indicated that toothfish was only one of the many fisheries products in their business and there were other comparable products available in the market. The proposed control scheme would not have a direct impact on their business.
- Majority of the importers were aware of the catch documents and the Catch Documentation Scheme (CDS) for toothfish. Their initial view was that the proposed control scheme would not cause too much burden on their operation. Some, however, have raised some questions about the operational details of the proposed control scheme.
- The seafood trade requested that the application and inspection procedures under the proposed control scheme should be simple and user-friendly.
- Some retailers were concerned about their possible liability under the proposed control scheme, and opined that the scheme should not target the retail level.
- Environmental groups indicated their support to the proposed application of the Convention to Hong Kong and the proposed control scheme for the trading of toothfish.
 They requested the government to deploy adequate resources for enforcing the control scheme in the future.
- They requested the government to fully implement the measures under the CDS, and conduct regular and *ad hoc* enforcement actions to combat the illegal trade. Some were also of the view that appropriate actions should be taken at the market (retail) level.
- Some environmental groups requested for improvements on the compilation of the trade statistics on toothfish upon the implementation of the proposed control scheme.
- Some environmental groups suggested that the government should take a more active role in other international fisheries conventions or measures implemented by other regional fisheries management organisations to combat illegal, unreported and unregulated fishing.
- All stakeholders considered it necessary for the government to organise education and publicity programme for the trade as well as the public in general.
- All stakeholders agreed that the government should maintain a close contact and continue the communication with them regarding the development of the proposal.
