

如何避免你的寵物被扣留？

“預先查核文件”

警告

特別許可證的持證人須嚴格遵從列於許可證上的所有條款。倘未能遵守所述之條款，有關動物或禽鳥可能須被遣返出口國/地方，或如高級獸醫官所決定在港接受檢疫，一切費用和風險將由持證人承擔，而持證人亦可能因未能遵守許可證上之條款而遭檢控。

務請遵照以下步驟……

- 步驟一：** 請細閱特別許可證上註明的條款。
- 步驟二：** 根據許可證的條款備妥所需文件。請注意，貓隻及狗隻必須植入微型晶片以作識別，並於健康證明書上列出該微型晶片的號碼，詳情請參閱許可證附件所載的有關條款。
- 步驟三：** 準備文件時，如有任何疑問，請致電下述熱線向我們查詢。
- 步驟四：** 在付運動物前，應以傳真或電子郵件方式遞交文件的副本給本署查核，這樣可避免有關動物於抵達後因未能符合許可證條款而被扣留檢疫。
- 步驟五：** 請來電跟進，以確定所遞交的文件是否有效。經本組預先查核覆實，就不用掛心。

How To Avoid Your Pet's Detention?

“ Prior Document Screening ”

WARNING

The permittee named in the Special Permit shall ensure that all terms of the Special Permit are strictly complied with. Failure to do so shall render the animal(s)/bird(s) liable to be repatriated to the country/place of export or quarantine for a period determined by the Senior Veterinary Officer at the cost and risk of the permittee, and the permittee may be prosecuted.

Important guide to follow.....

- Step 1:** Do read the TERMS stipulated in the Special Permit granted to you.
Prepare all the required documents in accordance with the permit terms. Please note that dogs and cats must be implanted with a microchip for identification and the microchip number has to be shown on the health certificate. For details, please refer to the relevant terms on the attachment of the Special Permit.
- Step 2:**
- Step 3:** Contact us via our hotline for advice in case of doubt while preparing your documents.
- Step 4:** Copies of documents should be submitted for checking either by fax or email prior to shipment. This can prevent your pet from detention for quarantine due to non-compliance with the permit terms on arrival.
- Step 5:** Do follow up to give us a call for confirmation on the validity of your prepared documents. Our prior checking service will put your mind at ease.
