To : Public who wishes to hire methyl bromide fumigation service in Hong Kong for quarantine or pre-shipment treatment of export consignments.

**Fumigation certificates issued by company not approved by AFCD for methyl bromide fumigation**

Overseas countries may require fumigation certificates to accompany import consignments. The certificate verifies that the concerned consignments have been fumigated with the pesticide methyl bromide for quarantine and pre-shipment purposes as specified by the importing countries. In Hong Kong, methyl bromide fumigation is regulated under the Pesticides Ordinance, Cap. 133 administered by this department. At present, we have approved 9 Hong Kong companies to conduct methyl bromide fumigation. The current list of approved companies is provided below:

2. Recently, this department has received reports concerning fumigation certificates issued by a company not approved for conducting methyl bromide fumigation in Hong Kong. However, this company erroneously claims on its fumigation certificates to be an agent approved by this department. I would like to draw your attention on this matter and remind you to hire methyl bromide fumigators approved by this department. Otherwise, your export consignment may have problems in entering the importing countries.
