- 6. During the quarantine period, if any of the animals under quarantine departs from Hong Kong for any other country/place, the owner must make an appointment with AFCD at least 7 working days prior to departure. The owner will be required to provide suitable transportation for AFCD Officer to escort the animals under quarantine to the port of departure between 8.30 a.m. and 5.00 p.m. from Monday to Friday excluding public holidays. All fees incurred by such shipment are paid by the owner.
- 7. The owner must acknowledge that an AFCD Officer may visit the quarantine premises at any time during the quarantine period while the dog is under quarantine and, agree to co-operate in this matter with the AFCD officer.
- The owner must acknowledge that all animals under quarantine will remain under quarantine surveillance for not less than 30 days as specified in the "Provisional Date of Release from Quarantine", or for a period as determined by the Senior Veterinary Officer of AFCD.
- 9. The owner must acknowledge and understand that an AFCD Officer may exercise powers under the Public Health (Animals and Birds) Ordinance (Cap 139) and the Rabies Ordinance (Cap 421), including requiring any or all the animals under quarantine to be inspected, treated, tested or removed to an animal quarantine station.
- 10. At the end of the quarantine period, the owner must take the imported dog to AFCD for examination by an AFCD Veterinary Officer to determine whether the imported dog can be released from quarantine. The owner shall call 2150 7141 to schedule an appointment during office hours at least 7 working days in advance before the end of quarantine period. The imported dog must be on leash and muzzled, and under direct control at all time when travelling from the quarantine premises to AFCD for its appointment.

- 8. 狗主必須承諾所有受檢疫動物將按照"暫定完成隔離檢疫的日期"接受不少於檢疫30天, 或由漁護署高級獸醫師所指定的檢疫期。

- 10. 在檢疫完結時,狗主必須把進口狗隻帶到漁護署,由漁護署獸醫師檢驗,以確定狗隻是否 適合完成檢疫。狗主應在檢疫期結束前至少7個工作天致電 2150 7141 與漁護署職員預約。 而由上述檢疫處所前往漁護署的整個行程中,狗隻必須完全受控,繫著狗帶及戴上口罩。
