備註Remarks:

1. 年齡未足60日大或懷孕多於 4 星期的貓狗不得入口。Dogs and cats less than 60 days old and or more than 4 weeks pregnant must not be imported.
2. 動物健康證明書及傳染病防疫注射證明書合併為一份證明書亦可予接納。證明書須由政府聘任之全職獸醫官簽署及蓋章；或經註冊之獸醫簽署及蓋章及由政府聘任之全職獸醫官加簽。A combined Animal Health and Vaccination Certificate is acceptable. The certificates must be signed and stamped by either a full time salaried government veterinary officer or a registered veterinary surgeon and endorsed by a full time salaried government veterinary officer.
3. 為方便正確證明，動物健康證明書應使用與本署在發出許可證時所夾附指定的表格(表格編號:VC-dad) 或相類似的證明書。To facilitate correct certification, an Animal Health Certificate (Form No.:VC-dad), issued together with the permit) or equivalent should be used.
