- 2. 動物健康證明書及傳染病防疫注射證明書合併為一份證明書亦可予接納。證明書須由政府聘任之全職獸醫官簽署及蓋章;或經註冊之獸醫簽署及蓋章及由政府聘任之全職獸醫官加簽。A combined Animal Health and Vaccination Certificate is acceptable. The certificates must be signed and stamped by either a full time salaried government veterinary officer or a registered veterinary surgeon and endorsed by a full time salaried government veterinary officer.
