(3) The permit will be valid for 6 months and is good for one consignment only. (4) Final travel arrangements should NOT be made until a permit has been granted. (5) Animals/birds must be transported by the fastest and most direct route as MANIFESTED CARGO. If travelling by air they must be covered by an air waybill.
