申請人注意事項

- (1) 所有資料必須以英文正楷填寫或以打字機列印。(英語、法語及西班牙語為公約[#]的官方用語。)
- (2) 一份申請表可供申請出口同一付運批次的多種物種之用，如多於壹種物種必須填寫 AF245 申請表附頁。
- (3) 在遞交申請表時，必須附上有關證明文件的影印本(先前出口地公約[#]出口准許證或按個別情況所需的產地來源證以及發票)。
- (4) 本署一般需時二個工作天處理每份申請，但倘若申請表上的資料填報不齊或欠缺所需文件，處理將會有所延誤。如須向公約[#]秘書處或其他公約[#]管理機構核實資料，或須查驗瀕危物種標本，則需更長時間。
- (5) 本署簽發再出口證明書須收取有關費用，有關最新收費可參閱本署網頁 <http://www.cites.hk/>。

NOTES TO APPLICANT

- (1) Information should be written or typed in BLOCK LETTERS in English. (English, French and Spanish are CITES[#]'s official and working languages.)
- (2) An application could be made for more than one species in each consignment. If more than one species, you should fill in annex to AF245 application form.
- (3) Photocopies of all supporting documents (eg. CITES[#] Export Permit of the country (region) of previous export or Certificate of Origin as the case may be and invoice(s)) should be submitted with the application.
- (4) Normally 2 working days will be required for processing an application. However, delays may be resulted if the application is incomplete or supporting documents are lacking. A longer processing time may be required if the application involves checking with other CITES[#] Management Authorities or the CITES[#] Secretariat, or inspection of the specimens.
- (5) Appropriate fee will be charged for the issue of a Re-export Certificate. For the latest fee, please refer to this department website <http://www.cites.hk/>.
