申請人注意事項

- (1) 所有資料必須以英文正楷填寫或以打字機打印。〔英語、法語及西班牙語為公約[#]的官方用語。〕
- (2) 申請人須為每個存放處所申請個別的管有許可證。
- (3) 在遞交申請表時，必須附上有關證明文件的影印本〔例如：進口許可證或供應商持有的管有許可證，以及證明有關交易的發票及文件等〕。
- (4) 本署一般需時二個工作天處理每份申請，但倘若申請表上的資料填報不齊或缺所需文件，處理將會有所延誤。如須向公約[#]秘書處或其他公約[#]管理機構核實資料，或須查驗瀕危物種標本或存放處所，則需更長時間。

- (1) Information should be written or typed in BLOCK LETTERS in English. (English, French and Spanish are CITES[#]'s official and working languages.)
- (2) Applicant shall apply a separate Licence to Possess for each keeping premises.
- (3) Photocopies of all supporting documents (e.g. Licence to Import or Supplier's Licence to Possess and invoices or documents showing all the transactions, etc.) should be submitted with the application.
- (4) Normally 2 working days will be required for processing an application. However, delays may be resulted if the application is incomplete or supporting documents are lacking. A longer processing time may be required if the application involves checking with other CITES[#] Management Authorities or the CITES[#] Secretariat, or inspection of the specimens or the keeping premises.
- (5) Appropriate fee will be charged for the issuance of a licence. For the latest licence fees, please refer to this department website <http://www.cites.hk/>.
