

指導大震 2013 Hong Kong Underwater MIL大信 2013 Photo & Video Compatition

漁農自然護理署(漁護署)和香港潛水總會(總會)將會合辦「香港潛攝大賽二〇一三」 ,以宣傳香港美麗的海洋生態及海洋生物,加強公眾對海洋環境保育的意識。

持有有效潛水牌照的潛水員。所有參賽作品必須展現香港水域的海洋生態、生境或 海洋生物, 並於2012年10月1日至2013年9月16日期間在香港水域拍攝或錄影。參 春作品必須是參賽者的個人照片或錄影,參賽前不曾出售、出版或參與任何其他攝 影比賽。所有與主辦單位有關之工作人員不得參加比賽。

數碼攝影 (參賽者須以個人身分參加。) 水底攝影分為兩組別:

1. 微距照片: 中60mm 至 200mm 焦距鏡頭所拍攝之照片

II. 標準及廣角照片:由14mm至50mm焦距鏡頭所拍攝之照片

参賽作品必須為原作照片,初步提交之照片檔解像度不超過 1200 x 1600 (4:3)或 1200×1800(2:3)。除了輕微的調整,好像全畫幅白平衡、亮度、對比度、色彩飽 和度的調整、銳化及裁剪等,大會不接受電腦後期處理的照片,例如合成照或顏色

参賽作品—旦入圍,参賽者必須同時提交作品之原生檔 (JPEG/TIFF/RAW),及作展覽 用徐之輕度矯正檔案。輕度矯正定義包括:不多於百分之十的色彩、曝光及裁剪矯正 。而該檔解像度不少於 2400 x 3200(4:3)或 2400 x 3600(2:3)。如入選作品未能提 交原牛檔,該作品將有機會被取消資格。

参謇者敬請在拍攝前將相機日期調校正確。

参賽者可參加一個或所有組別,每組別提交不超過10張照片。

數碼錄像(參賽者可以個人或隊伍名義參加。)

参賽作品在整個製作過程,會涉及多個部份,如編導,攝影,音效,剪接,為提高 作品質素及發揮團體精神,鼓勵參賽者組隊參加,非潛水員亦可參與前期及後期工 作,個人亦可擔任名個角色

参賽作品必需為720i標清解像度或以上。剪裁後的短片限於1.5分鐘內。格式須為 H 264/MPEG-4

如短片包含背景音樂,此等音樂須為免版稅音樂,參賽者不得侵犯任何版權。

参賽者可提交不超過3段短片。

参賽者可編輯短片,但應盡量減少使用合成圖像及電腦動畫。至少有75%的短片應

Entries must be in 720i Standard-definition (SD) resolution or above. Edited video clip should not be longer

Accompanying music, if included in the video, should be royalty free and not infringe on any copyright.
