The information required in Annex 10-03/A must be provided by the vessel master. The CCAMLR IUU Fishing Declaration and CCAMLR Compliance Declaration must be made and signed by the master.

(Note: If the Notification Form is submitted by post, please allow sufficient time for the post to reach this Office to ensure that the Notification Form is given to the Director of Agriculture, Fisheries and Conservation (“the Director”) at least 48 hours before the intended entry of the fishing vessel).
