**Conservation of Antarctic Marine Living Resources (Toothfish Catch Documentation Scheme) Regulation, Cap.635A**

**犬牙鱼再出口许可证申请表**

1. 本申请表可用于申请一张犬牙鱼再出口许可证，以涵盖由同一船只 / 飞机 / 车辆 / 火车再出口的单一货运（每一货运可包含一批或多批装运的犬牙鱼产）。如再出口的犬牙鱼产会以多于一架船只 / 飞机 / 车辆 / 火车运离香港，申请人应就每次货运 / 运输，申请单独的再出口许可证。This application form can be used to apply for a Toothfish Re-export Licence to cover a single shipment of toothfish item(s) to be re-exported on the same vessel/aircraft/ vehicle/train (each shipment can include one or multiple consignment(s) of toothfish item(s)). If the toothfish items will be taken out of Hong Kong by more than one vessel/aircraft/ vehicle/train, the applicant should apply for a separate re-export licence for each shipment/transport.

(ii) I understand that Re-export Licence, if granted, is granted in reliance on the information provided and declared in this application form and is subject to the Conditions of Licence and any other conditions that the Director of Agriculture, Fisheries and Conservation may impose. I have read and hereby undertake to abide by those conditions and any other conditions which the Director of Agriculture, Fisheries and Conservation imposes regarding the re-export of the goods declared on this application.

(iii) I undertake to inform the consignor(s) of the goods of the Conditions of Licence and other conditions imposed by the Director of Agriculture, Fisheries and Conservation regarding the re-export of the goods declared on this application.

(iv) I understand and agree that all or any of the information including personal information provided in this application form may be disclosed by the Agriculture, Fisheries and Conservation Department to third parties either in Hong Kong or elsewhere, including, but not limited to the Commission for the Conservation of Antarctic Marine Living Resources, the Contracting Parties and non- Contracting Parties cooperating with the Convention on the Conservation of Antarctic Marine Living Resources and other Government departments, bureaux, relevant organizations and any person, if such disclosure is necessary to facilitate consideration of the related application, for the purposes of implementing the Convention on the Conservation of Antarctic Marine Living Resources or any Conservation Measure; is in the public interest; is authorised or required by the law; or if explicit consent to such disclosure is given by the applicant/data subject.
