Dear Sir/Madam,

Addition of Pesticide Registration Condition

In view of the growing public concerns over the safety of pesticides, the Agriculture, Fisheries and Conservation Department has reviewed the registration of pesticides which are classified as extremely hazardous or highly hazardous according to the World Health Organization. In order to protect human health and public safety, in addition to the existing restrictions in relation to supply and retail sale, this Department will add a registration condition to impose restrictions on the maximum concentration and formulation of the following pesticides allowed for import with effect from 15 June 2016.

Effective from the same date (i.e. 15 June 2016), import, supply and retail sale of the above-listed pesticides will be subject to the specified maximum concentration and formulation as listed in the appendix. Pesticides traders who engage in the trade or business of the pesticides should ensure full compliance with the newly added registration conditions. Failure to comply with the registration condition is a breach of the condition of the Pesticides Licence issued under the Pesticides Ordinance (Cap. 133), which may result in the cancellation of the Licence, a fine and imprisonment upon conviction.
